Dear Sirs;

the IFBB has had knowledge and evidence that Mr. Alejandro Santos Ospina, already President of the Federacion Colombiana Fisicoculturismo (FCFC) is not fulfilling the two years suspension period (from September 18th,2014 to September 17th , 2016 inclusive)from every charge, office and activity in the FCFC, imposed him through the IFBB Disciplinary Commission adjudication November 29th, 2014, carrying 'de facto' his activity as FCFC President, with the active support of the Colombian Federation Executive Board.

So, the IFBB Executive Council, in accordance with the provisions 14.8.1, 14.8.3 of the current IFBB Constitution, has opened a disciplinary file against the Colombian Federation (FCFC) and has resolved to suspend provisionally -effective immediately- the current Colombian Federation Executive Board, awaiting the final adjudication about the issue.

As a consequence, from now on -until the final adjudication of the IFBB Executive Council - all the activities of the Colombian Federation (included, but not limited to the competition ' s ambit) will be directly structured and administered by a 'pro tempore ' Commission headed by South American Federation President, Lcdo. Juan Paredes.

This communication applies as official communication to the persons concerned and to their National (FCFC) and Continental (CSFF) Federation.
